VPLC's 43rd Annual Statewide Legal Aid Conference is Virginia's premier poverty law conference. The multi-day conference provides free comprehensive CLE-accredited training on civil poverty law issues to the legal community and others working in the poverty law sector.

What began as an educational event for Virginia's legal aid community has grown to include JAG Corps members, probono attorneys, board members and community stakeholders. In 2022 more than 500 people attended either in-person or virtually and had access to over 40 educational sessions.
